Lobbying Firm Broke PAC Rules

Former top aides to Sen. Rick Santorum (R-Pa.) who are working at a lobbying firm with close ties to the lawmaker appear to have used their political action committee in ways that repeatedly broke federal election rules in recent months.

The firm, Pittsburgh-based GSP Consulting, already refunded in March more than \$25,000 in excessive contributions to its PAC.

However, when Roll Call brought other apparent infringements to the firm's attention Monday, GSP co-founder John Dick said he was moving to correct the situation.

The apparent violations — which Dick said he had been unaware of — include accepting PAC contributions from people outside the firm, failing to notify the Federal Election Commission of an affiliation with another PAC and breaking spending limits for affiliated PACs with contributions to Santorum.

He said the firm has requested that Santorum's re-election campaign return \$600 in excessive contributions; was refunding a client's contribution to its PAC; and is seeking guidance on whether it broke FEC rules by failing to report its association with another campaign fund.

Firm officials described the mistakes as the unintentional result of relatively inexperienced consultants wrangling with complex federal regulations.

"We're young, and our PAC is pretty young as well, and we're trying to manage it all," said Amy Ross, a GSP principal who manages the fund. "It was just an honest mistake."

FEC spokesman George Smaragdis declined to comment on the situation, citing agency policy not to discuss possible or pending actions. He noted that the firm responded promptly earlier this year when notified of the excessive contributions to its PAC.

Dick said he is hopeful the FEC will continue to be forgiving of his outfit's mistakes, given the difficulty of complying with federal rules.

But Brett Kappel, a campaign finance lawyer with Vorys, Sater, Seymour and Pease, said the firm's professed innocence may not keep federal campaign regulators at bay.

"This PAC appears to have committed several egregious violations of the Federal Election Campaign Act," Kappel said. "Having multiple violations on their record is more likely to lead to an FEC audit or an enforcement action seeking civil penalties."

The lobbying shop, which focuses on appropriations work for Keystone State clients, was launched in 2001 by Joseph Kuklis and Dick, who together logged several years on Santorum's staff.

Dick, who served as Santorum's director of business coalitions and deputy campaign manager, and Kuklis, the Senator's one-time deputy state director, began small. They opened their operation in the same Pittsburgh building where the Senator has his office, and they recruited a small stable of clients.

They launched the PAC shortly after opening their doors. While the fund has remained relatively small — it has pulled in \$36,000 this cycle — GSP lobbyists have maximized its impact by targeting donations to just a handful of lawmakers from the western Pennsylvania region.

This aggressive political activity has helped the firm nearly quadruple its lobbying revenue in just the past few years, from \$320,000 for the first half of 2003 to \$1.2 million for the first half of 2005, according to figures from PoliticalMoneyLine.com.

One of the more egregious breaches involved a \$15,000 donation accepted late last year from a client, Charles Hammel, president of a Pennsylvania trucking company called Pitt Ohio Express, for whom GSP is seeking federal funding and lobbying on tax issues.

That move represents an apparent violation of federal rules restricting PAC contributions to company employees, as well as being a violation of contribution limits. The firm returned \$10,000 of that money after the FEC caught the second problem but not the first.

Now, firm officials said, they will return to Hammel the remaining \$5,000 they had accepted in violation of federal rules.

Beyond the Hammel check, GSP officials appear to have stepped outside the law by failing to tell the FEC when they created a second "affiliated" campaign fund under the rubric of a joint venture with Houston Harbaugh, a Pittsburgh law firm.

When firms already operating PACs set up other campaign funds, federal regulators require notification, since FEC rules dictate that dollars doled out by the secondary funds be counted against caps on the originals.

GSP appears to have violated those limits, contributing \$4,100 to Santorum's re-election campaign from the original PAC plus another \$1,500 from the fund of the side project, called Houston Harbaugh Legislative Services. The total \$5,600 in donations to the Senator's re-election effort exceeds the \$5,000 per-election limit on PAC contributions, prompting the firm to request a \$600 reimbursement after being notified of the breach Monday.

"The Santorum campaign follows all laws and rules as set forth by the FEC," Santorum campaign spokeswoman Virginia Davis said in a statement. "When contribution limits are exceeded, the campaign returns that contribution or portion of it in a timely manner."

GSP Consulting has seen its business soar since its launch by tapping into a growing trend in the lobbying business. With more federal dollars available for pet projects and a greater recognition of the fact by private-sector groups, lobbying firms specializing in clients from one geographic area have been able to trade on close ties to a single Congressional delegation.

By focusing on Pennsylvania lawmakers, GSP officials have secured \$35 million in federal help for their clients since the firm's founding, according to a recent report.

They now have about 50 federal clients, for whom they boast returns of 19 times the client's outlay. And the firm now has a staff of 16, including three more staffers who worked for Santorum.

"Growth," the firm's Web site, www.gspconsulting.com, announces. "GSP Consulting lives, eats, and breathes it. We are addicted to it."

Dick said that GSP principals consider their ethical standards to be a strength, adding he regrets that the nature of the business requires the firm to play in the political money game.

"It plays an unfortunately significant role in all of it," he said. "It's definitely a necessary evil."

GSP Consulting buys Houston Harbaugh's lobbying arm

Lobbying firm **GSP Consulting** has acquired **Houston Harbaugh Legislative Services**, which it jointly launched two years ago with one of Pittsburgh's largest law firms.

GSP bought the stake of **Houston Harbaugh PC** for an undisclosed price.

Houston Harbaugh Legislative Services was created to provide lobbying services to organizations in health care and economic development. Both GSP, a Pittsburgh-based firm, and Houston Harbaugh said the sale was prompted by HHLS's rapid growth.

"We started the joint venture to develop a new lobbying government affairs consulting arm of the law firm that would track different clients than GSP normally pursues," said GSP founder Joe Kuklis. "We lent our government affairs expertise, they lent rolodexes and a stable of lawyers who could develop quality leads, and we both put in some sweat equity."

Two of HHLS's three employees join GSP -- Dennis Troy, former director of economic development for Allegheny County, and Shawn Good, former director of government affairs for the Pittsburgh Chamber of Commerce. GSP will absorb HHLS's clients.

Kuklis said South Side-based GSP will continue working with Houston Harbaugh and that the firm's founder, Greg Harbaugh, is joining GSP's board of advisors.

Since its founding in 2001, GSP has generated more than \$330 million for clients, mostly in the technology and life sciences sectors, from federal, state and local government sources. It employs 15 and has offices in Harrisburg, Philadelphia, Cleveland, Tampa and Ann Arbor.

Houston Harbaugh, launched in 1975, employs 37 lawyers. According to the Business Times list published Jan. 21, it is tied with **McGuire Woods LLP** as Pittsburgh's 18th-largest law firm, ranked by the number of lawyers in Pittsburgh.

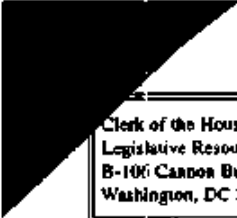





From staff to lobbyist: The ties that bind

When John Dick and Joseph Kuklis left Republican U.S. Sen. Rick Santorum's office, they picked the profession of many former staffers. They became lobbyists.

They moved into the same building where Santorum has his Pittsburgh office, hired a staff with ties to Democratic and Republican officeholders, started a political action committee, and landed \$35 million in appropriations, often for firms that had never received federal money before.

It's the way Washington works, but the practice is under scrutiny after a string of corruption scandals that highlighted the explosion in congressional pet projects and the industry that has built up around them.

In the last decade, the number of registered lobbyists has tripled to nearly 33,000 and the amount of so-called earmarks -- money for projects that lawmakers attach to spending bills -- topped \$29 billion.

A small circle of former staffers to Santorum and Sen. Arlen Specter, R-Pa., have, in turn, made earmarks their business, acting as the middlemen between clients and Pennsylvania's congressional delegation in winning more than \$100 million in appropriations since 2001, according to public records, interviews and analysis by The Inquirer.

The National Center for Defense Robotics hired Dick's firm, GSP Consulting, in 2002 and has won \$7.5 million since then. During that time, the center's president and his wife gave \$11,000 to lawmakers, including Rep. John P. Murtha, D-Johnstown, and Rep. Michael F. Doyle, D-Swissvale -- both of whom supported the projects, Dick said.

After hiring a former top Specter aide, Pittsburgh's Start Smart Foundation collected \$75,000 in 2002 to establish a substance-abuse prevention program and \$225,000 in 2003 to expand it. A month before winning the initial award, founder William Hinchey began writing the first of seven campaign checks totaling \$4,850 for Specter, who took credit for the grants. The nonprofit dissolved last year.

The former staffers to Santorum and Specter who work on appropriations tend to be more generous donors than their former colleagues who focus on policy. They gave at least \$170,000 since 2001, records show.

The system has fierce defenders.

Santorum, Specter and their spokesmen say earmarks make up a fraction of annual government spending, and the projects -- bioscience research, cutting-edge medical equipment, mass transit -- are valuable. They are vetted by multiple aides and awarded on merit, never campaign support, they say.

The influence of one lobbyist or donation is "nil," said William Reynolds, Specter's chief of staff. "I could care less who is bringing them in, frankly. Not that I am not friends with the people bringing them in. I don't give a rat's butt."

Outsiders see it differently.

The perception is fed, in part, by the process. Requests often evade public scrutiny, and the recipients and sponsoring lawmakers can be difficult to track.

"This is sort of the inside-the-Beltway version of machine politics," said Keith Ashdown, vice president of Taxpayers for Common Sense, a nonpartisan Washington group. "Your staff goes to K Street to make money, and you want to take care of them because they are on your team, and they want to return the favor by contributing money. It is back-scratching at its worst."

Credibility in connections

It was the tail end of the dot-com boom, and Dick and Kuklis saw a niche to fill.

They were doing business outreach in Santorum's Pittsburgh office to the region's growing high-technology sector. Money from venture capitalists started drying up, and the firms, in need of funding, asked for lobbyist references.

"I referred them," Dick said, "but they all came back and said: 'John, these lobbyists want \$10,000 guaranteed retainers. They want us to make contributions to their PAC. We are not ready to do that yet. Is there an alternative?' And honestly, there was not."

Dick and Kuklis opened a firm and aimed to be different.

They charged lower fees than their peers on K Street, the Washington address of many lobbyists. They declined to move there.

But they could not reject every hallmark of the K Street culture.

Seven GSP associates out of 16 have worked as congressional staffers, including three with Santorum and one each with Murtha and Doyle.

Expertise and work ethic mattered most in their hiring, Dick said, but so did connections. "I wish it weren't that way," he said, "but the fact is, it saves you a lot of time developing credibility with people."

Asked whether Dick suggests to his clients that they contribute money, he said: "Sure, it is an unfortunately big part of it... It is definitely in our interest to support candidates that care about our projects and issues."

Since 2002, GSP's PAC has contributed \$27,500 to members of Congress, divided evenly between the parties, but concentrated in Western Pennsylvania, the home of lawmakers often lobbied by GSP.

In 2004, GSP noted on its PAC finance reports its contributions to members of Congress on behalf of individuals, some of whom wanted -- or had already received -- its help.

The committee passed \$2,000 to Santorum and \$250 to Doyle in July 2004 -- designating the source as Sean McDonald, the CEO of Precision Therapeutics, who also gave \$1,500 directly to Murtha several months earlier, records show. Around the same time, the Pittsburgh developer of cancer-treatment technology was seeking funding and help on a Medicare reimbursement issue.

"GSP immediately employed the assistance of key congressional leaders to break the bureaucratic logjam in Washington," GSP states in a "client case study," which also details how Precision Therapeutics obtained \$3.5 million in funding. Dick credited Santorum, Doyle and Murtha, among others.

McDonald did not respond to a request for comment.

William Thomasmeyer, president of the National Center for Defense Robotics, also opened his checkbook over the same period he won federal funding. Responding to questions via e-mail, Thomasmeyer said the donations were "absolutely not" a factor in the awards.

Dick said contributions connected to his firm are never made for official action.

"You will find no stronger advocates of lobbying reform than my business partner and I. It will level the playing field for a firm like ours, which isn't doing junkets to Scotland," Dick said, referring to lobbyist Jack Abramoff, who pleaded guilty to fraud charges in January.

Dick is one of at least two dozen former Santorum aides who have become registered lobbyists since 1998. Specter graduated nearly as many, according to interviews and disclosure records.

About a dozen of them seek earmarks, records show. They also pepper lawmakers with contributions -- at least \$170,000. However, one staffer beyond that circle stands out: Mike Mihalke, a Santorum press aide until 1995, spread \$116,000 around the country as a partner since 2003 at Alexander Strategies Group, which has been linked to three corruption investigations. Disclosure forms show that he lobbied mostly on policy, but he had sought defense money for three clients.

Since joining American Continental Group in 2002, David Urban, a former Specter chief of staff, has built a deep roster of clients and given at least \$60,000, almost entirely to GOP lawmakers.

In that time, he helped land at least \$13 million for nonprofits and defense contractors, including Air Products, of Lehigh County, and JLG, of Fulton County. He teamed with other lobbyists to get \$46 million for Philadelphia's mass transit system and \$22 million for Drexel University. In news releases, Santorum and Specter claimed credit for a majority of these projects.

Another Specter chief of staff, Craig Snyder, took a similar path, becoming a partner at Ikon Public Affairs. The firm also employs Peter Grollman, who advised Specter on grants and appropriations. Together, they have obtained at least \$11.8 million for clients since 2001 and contributed \$70,000 to lawmakers, records show.

Snyder's connection convinced William Hinchey, a Lehigh Valley marketing executive who decided to leave his job in 2001 and start a nonprofit that targeted alcohol abuse. He also wanted federal money.

"I thought, here is a guy who used to work for Arlen Specter as his chief of staff," Hinchey said. "He probably knew how to do this stuff."

Snyder guided Hinchey toward \$75,000 for his Start Smart Foundation, which got an additional \$225,000 on its own the next year. The group put 120 families through an abuse-prevention program.

Discouraged by federal red tape and unwilling to continue investing his money, Hinchey closed the foundation last year.

Reynolds, Specter's current chief of staff, said the program was a "good-faith attempt to help a problem."

No end for earmarks

Immersed in a tough re-election fight, Santorum put himself at the center of the Senate's effort to change lobbying rules.

But the Senate passed a bill last month that left the earmarking process largely intact. It would require senators to identify the project's source and purpose, but Ashdown, of Taxpayers for Common Sense, said loopholes would allow many to remain hidden. The House has yet to take up the bill.

Santorum's leading Democratic opponent, Bob Casey Jr., has criticized the senator for his role in an "out of control" system. If elected, Casey said, he would seek earmarks, but more disclosure could reduce waste.

For his part, Santorum concedes that he is an earmark fan.

"The money is going to be spent," he said. "It's either the Congress that decides where this money goes or the bureaucracy decides."

Two days after the Senate vote, Santorum was back on the check-presentation circuit.

With 75 supporters gathered in the town square, Santorum signed an oversize \$200,000 check to Oxford Mainstreet Inc., a downtown-revitalization group in Chester County.

The reason? Streetlights.

"I mean, these are projects that add real value to the community," Santorum said. "I am not building bridges to nowhere."
